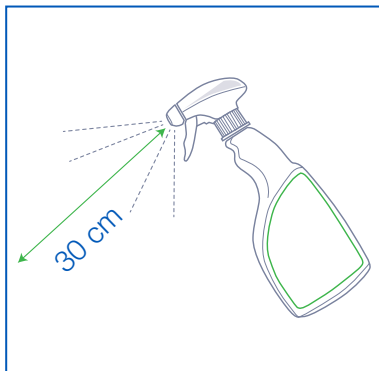
Intended Use / Intended Purpose:



For the surface disinfection of non-invasive medical devices. Alcohol is not recommended for use on dental/medical instruments.



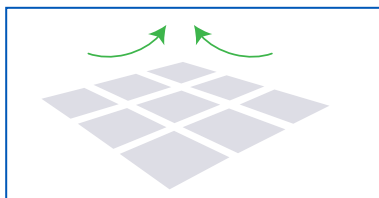
For the disinfection of surfaces. Use biocides safely and sustainably. This product should be used in accordance with the product label. PT2 Formulation type: AL.



1. Spray clean surfaces and objects to be disinfected from a distance of 30cm so that they are completely moistened.



2. Let the disinfectant take action for 60 seconds.



3. Allow surface spray to evaporate. See product labels and MSDS for further information.

Indications / Efficacy (60 secs): Bactericidal including VRE. Yeastocidal. Mycobactericidal. Tuberculocidal. Viruses to include: Non-enveloped viruses: Murine norovirus, Adenovirus 5. Enveloped viruses: Hepatitis B virus (HBV), Hepatitis C virus (HCV), Hepatitis Delta virus, HIV, Influenza virus, Coronavirus, Herpesviridae, Filoviridae (Ebola), Rubella, Rabies, Measles, Poxviridae.

Tested to Standards: EN14885, EN14476, EN14348, EN13727, EN13697, EN13624.

Composition: Ethanol (64-17-5) 63% w/w (630g/kg), Aqua, Perfumes (Contains Linalool, Citral, Geraniol, Alpha-Isomethyl ionone).

Contraindications. Do not use on surfaces sensitive to alcohol.

Disposal. Dispose of contents/container in accordance with local regulations. Do not discharge into drains or rivers.

Intended Users. For professional use only. The products are used within the dental surgery by the dentist or dental assistant as part of their general disinfecting routines.

Patient Population: Dental surgery patients, both adults and children.
